

CONTEST RULES

This Lakeridge Health Foundation Hockey Stick Facebook contest (the "Contest") is subject to the following terms and conditions (the "Rules"):

1. Eligibility to Enter the Contest: The Contest is open to all Facebook users (the "Eligible Participants" or "Participants"). Employees of Lakeridge Health Foundation (the "Foundation") and the current Board of Directors of the Foundation, including members of their respective immediate families are not eligible to enter this Contest. The employees of the company that donated the prize are not eligible. The Contest begins Dec 12, 2017 10:50 a.m. and ends Dec 19, 2017 12 noon.

2. How to Enter the Contest: No purchase is necessary to enter the Contest. Participants must complete the following two steps in order to be considered eligible.

i) Like: Visit <https://www.facebook.com/lakeridgehealthfoundation> and "Like" the Lakeridge Health Foundation page. Contest post "Likes" will not be considered as acceptable contest entries.

ii) Share: Participants must "Share" the original contest post by Lakeridge Health Foundation to their Facebook friends and/or page followers.

3. Description of Prize: The prize in the Contest consists of one (1) game-used and autographed hockey stick by Allan McShane (the "Prize"). The approximate retail value of the Prize (\$300) does not include applicable taxes. The Prize must be accepted as awarded and is not transferable. No cash or other prize substitution will be permitted. The Prize will be awarded as-is, and the Foundation makes no warranty of any kind regarding the Prize in this Contest.

4. How the Winner is Selected: The winner will be selected in a random draw, held on Dec 20, 2017 by 12 noon, among all eligible entries received by the Contest Closing Date. All Entries must be received by Dec. 19 at 12 noon to be eligible for and included in the draw.

The odds of winning will depend upon the number of eligible entries received.

Following the random draw, the winner(s) will be notified of their win by private message through the platform the Contest exists. If a winner cannot be contacted within two (2) business days using reasonable efforts, or if a winner has not or does not comply with these Rules, the selected person will forfeit his or her prize, and an alternative winner will be randomly selected. The Foundation will not be responsible for failed attempts to contact a selected entrant.

The names of the prize winner may be posted on the Foundation's website and/or social media accounts following the contact of the winner, if permission is granted by the winner. If permission is not granted for the Foundation to post their name, a winning post will still deploy accompanied by copy that includes "The winner has been contacted. Thank you to everyone who participated!"

The Prize will need to be picked up by the winner at the Lakeridge Health Foundation Oshawa or Whitby offices, with accompanying proof of winner ID. The Foundation will not hand-deliver the Prize.

5. Participants' Obligations: By entering the Contest, the Participant agrees to abide by and be bound by these Rules. Non-compliance of these Rules may result in disqualification and forfeiture of the Prize by the Foundation.

By entering the Contest, or in the case of the winner, accepting the Prize, the Participant acknowledges that the Foundation has not made any representation, warranty, condition or guarantee, in respect of the Prize or its performance, it being understood and agreed by the Participant that the manufacturer of the Prize is solely responsible in respect thereof.

Limitation of Liability: The Foundation shall not be responsible for any telephone, technical, network, on-line, electronic, computer hardware or software problems, including any injury or damage to a Participant's or any other person's computer relating to or resulting from participating in this Contest.

7. General Conditions: The Foundation reserves the right in its sole discretion to disqualify from the Contest any Participant found (i) tampering with the Entry process, the operation of the Contest or the Foundation's website, (ii) to be acting in violation of these Rules, or (iii) to be acting in an unsportsmanlike or disruptive manner.

The Foundation reserves the right to alter these Rules without notice.
